The Countywide Oversight Board shall oversee the Successor Agencies in their wind down activities and in the expeditious liquidation of the assets of the former redevelopment agencies. The Countywide Oversight Board shall also have fiduciary responsibilities to holders of enforceable obligations and the taxing entities that benefit from distributions of property tax and other revenues pursuant to Health and Safety Code Section 34188 (see Health and Safety Code Section 34179 (i)).

Health and Safety Code Section 34179 (j) states in part that "*commencing on and after July 1, 2018, in each county where more than one oversight board was created by operation of the act adding this part, there shall be only one oversight board, which shall be staffed by the county auditor-controller, by another county entity selected by the county auditor-controller, or by a city within the county that the county auditor-controller may select after consulting with the department*". The County Auditor-Controller's office has selected the County Executive Office to staff the Countywide Oversight Board.
